Subject: Conduct of the 5th National Javelin Day Competitions – 2026

Dear Sir/Madam,

The Athletics Federation of India (AFI) organizes the National Javelin Day celebrations across the country every year on 7th August to commemorate the historic achievement of Neeraj Chopra, who won India's first-ever Olympic Gold Medal in Athletics at the Tokyo Olympic Games.

As part of this nationwide celebration, the Lakshadweep Athletics Association (LAA) has decided to organize the 5th National Javelin Day Competitions in all affiliated Units of Lakshadweep Athletics Association on 07 August 2026.

During the previous National Javelin Day celebrations, Lakshadweep recorded the highest participation in the country, with 511 athletes participating across all islands. Therefore, Lakshadweep Athletics Association expects even greater participation this year. All Island Units are requested to begin preparations well in advance, ensure proper planning and organization, coordinate with schools and sports clubs, and encourage maximum participation from athletes.

Let us work together to make the 5th National Javelin Day – 2026 a grand success across Lakshadweep.

Details and instructions to the competition as are follows.

Events:

- * Cricket Ball Throw: Under-14 Boys & Girls
- * Javelin Throw: Under-16 Boys & Girls, Under-18 Boys & Girls, Men & Women

For Bitra - Cricket Ball Throw: Under-14 Boys & Girls, Javelin Throw Men & Women

Age Eligibility (As on 07-08-2026)

- * Under-14: Born on or after 08-08-2012
- * Under-16: Born between 08-08-2010 and 07-08-2012
- * Under-18: Born between 08-08-2008 and 07-08-2010
- * Men & Women: Born on or before 07-08-2008

Cash Prizes (each category)

- * 1st – ₹500
- * 2nd – ₹300
- * 3rd – ₹200

1. Cash prizes, medals and certificates shall be distributed immediately after the completion of the competition at the competition venue. The prize distribution should not be postponed.
2. A Cash Prize Receipt shall be obtained from each prize winner at the time of distribution. A prescribed Cash Prize Receipt Format will be provided by the LAA. All winners shall sign the receipt after receiving the prize money.
3. Each Island Unit will be provided ₹2,500 towards the conduct of the competition. The expenditure shall be supported with proper original bills/vouchers. The amount may be utilized for certificates, medals, refreshments and other essential competition-related expenses.
4. The following documents shall be submitted to the Lakshadweep Athletics Association on the same day after completion of the competition:
 - * Category-wise results.
 - * A brief competition report.
 - * Cash Prize Receipt Forms duly signed by all prize winners.
 - * Original bills/vouchers for the utilization of the ₹2,500 competition grant.
 - * Soft copies of event photographs.
 - * Participation Summary in the prescribed format.
5. A Participation Summary Format will be shared separately. The following details shall be furnished:
 - * Under-14 Boys – Number of participants
 - * Under-14 Girls – Number of participants
 - * Under-16 Boys – Number of participants
 - * Under-16 Girls – Number of participants
 - * Under-18 Boys – Number of participants
 - * Under-18 Girls – Number of participants
 - * Men – Number of participants
 - * Women – Number of participants
 - * Grand Total of participants
6. The Participation Summary, Brief Report, Cash Prize Receipts, Bills/Vouchers, Competition Results, and Soft Copies of Photographs shall be emailed to the official email address of the Lakshadweep Athletics Association on the same day after the completion of the competition.

All Island Units are requested to strictly comply with the above instructions to ensure timely submission of reports and settlement of accounts.
